Preliminary Audit findings - two-week follow up

Board Administrator, Gina Rizzo explained that each member was sent the preliminary audit from PERAC approximately a week ago to review. The findings are before you. After review the board can disagree or agree with the findings but needs to provide PERAC with a response within two weeks. Members Ceballos and Cockroft were present during the exit interview. PERAC will have a 6 month follow up to make sure we have corrected the errors. I have been working with the auditors and I am in agreement that the 7 retirees do need to be recalculated. I'm in agreement on the amounts of 6 of them, 5 we overpaid and 1 was underpaid. I disagree with Joseph Jameson being overpaid, I feel he was underpaid due to an incorrect retroactive payment. These errors were through no fault of the individual and going forward I will be using PERACs recommendations for calculations.

Michael Sacco explained that as long as the retirees have been retired for more than a year, the board has the discretion to waive the past payments owed.

Diane Cockroft made a motion per PERAC findings to waive all back payments owed by retirees since they are not at fault and have been retired for over a year and issue amounts to retirees that were underpaid. Motion seconded by Sheryl Wright. Roll Call — Ceballos-yes, Wilson-yes, Ruiz-yes, Wright-yes, Cockroft-yes. Motion was approved on a unanimous roll call, 5-0.
