New Business:

The Board is in receipt of the completed medical panels for the **Ryan Jenks**, ordinary disability case. Michael Sacco has reviewed all relevant documents and provided an *opinion letter*.

Board Policy regarding Military Service Credit Purchases – Update per PERAC Memo #23/2024

Executive Director Rizzo explained that PERAC Memo # 23 has made substantial changes to the purchase of veterans creditable service. Myself and staff attended a webinar where PERAC has recommended boards update their policy regarding Military Service Credit Purchases. Although the board can set the terms of the purchase, PERAC isn't in favor of leaving the purchase "can pay up to date of retirement", which is what our board currently does. Michael Sacco has drafted a policy allowing 5 years to purchase and also allowing payroll deductions. Michael has also drafted a new Installment Plan Policy for Buybacks and Makeup payment mirroring the terms in order to keep things more uniform.

Diane Cockroft made a motion to adopt the new Board Policy Regarding Military Service Credit Purchases created September 2024. Motion was seconded by Sheryl Wright. Motion was approved unanimously 5-0.

Board Installment Plan Policy for Buybacks and Makeup payments - Update
